

# SUBARU 4WD club OF QUEENSLAND inc

## TEMPORARY MEMBERSHIP APPLICATION FORM

### Indemnity:

The Temporary Member must indemnify the Subaru 4WD Club of Queensland Inc. (including officers and agents of the Subaru 4WD Club of Queensland Inc.) from and against any loss, damage or expense (including legal costs), arising from any claim, demand, action, suit or proceeding that may be made or brought by any person against the Subaru 4WD Club of Queensland Inc. in respect of:

- (a) the death of or injury to any person; and
- (b) the loss of or damage to any property

Where such death, injury, loss or damage arises out of or in connection with the Temporary Member's activity on a nominated club event organised by the Subaru 4WD Club of Queensland Inc. and is caused by the negligent act or omission of the Temporary Member or a family member, employee, agent, invitee or client of the Temporary Member.

Provided that the Temporary Member shall not be liable for any liability or loss to the extent that it is the fault of the Subaru 4WD Club of Queensland Inc. Where negligence is found to have been contributory, each party shall bear full responsibility in accordance with the party's fault.

The Temporary Member must advise the Management Committee in writing of any death, injury, loss or damage described in (a) and (b) above immediately upon the Temporary Member becoming aware of such death, injury, loss or damage.

### Release and discharge:

The Temporary Member releases and discharges the Subaru 4WD Club of Queensland Inc. (including officers and agents of the Subaru 4WD Club of Queensland Inc.) from any claim, demand, action, suit or proceeding which, but for the provisions of this condition, may be brought against or made upon the Subaru 4WD Club of Queensland Inc. by the Temporary Member.
